
EXCLUSIVE CO-PUBLISHING & MASTER REPRESENTATION AGREEMENT

III. CORE TERMS & COMPENSATION

1. **Term:** The Initial Period is one (1) year, automatically renewing unless terminated with 30 days' written notice.
2. **Ownership:** Artist retains **100% of the Copyright** to the Composition and Master Recording.
3. **Sync Split:** All upfront synchronization fees (licensing for TV, Film, Ads, Games) shall be

split **50% to Publisher / 50% to Artist**.

4. **Performance Royalties:** Artist retains **100% of the Writer's Share**. Publisher shall collect the Publisher's share, split **50/50** with the Artist.

IV. THE "ITZGREEN" INDEMNITY (Legal Warranties)

1. **Human-Composition Guarantee:** Artist explicitly warrants that the Music is **100% human-produced**. Use of generative AI, algorithmic generation tools, or vocal cloning is strictly prohibited and grounds for immediate termination.
2. **Sample Clearance:** Artist warrants that the Music contains **NO uncleared samples**. Artist is solely responsible for any third-party clearances required for sync use.
3. **Indemnification:** Artist agrees to indemnify ItzGreen Music against any losses or legal fees resulting from a breach of the AI or sample warranties.

V. ADMINISTRATIVE POWER OF ATTORNEY

Artist grants Publisher a limited Power of Attorney to register the works with collection societies (BMI, The MLC, SoundExchange) and to execute synchronization licenses on the Artist's behalf.
